LOCATION

The premises is prominently situated on the corner of Flat Iron Square on the north side of Union Street at the junction with O'Meara Street. Borough High Street is approximately 250 meters to the west and London Bridge mainline and Underground (Jubilee and Northern lines) stations are within a short walk. Also, Borough Underground station (Northern line) is approximately 500 meters to the south.

Flat Iron Square is now a recognised restaurant and bar destination with other nearby operators including Audreys, Lupins, Where the Pancakes Are, Tap & Bottle, The Gentleman Barista, Rose & Crown Pub and Est. India.

The busy and popular Borough Market locality is approximately 530 meters to the north east and the River Thames/Bankside is circa 970 meters to the north (including the Tate Modern gallery and Globe Theatre).
